

CLUBHOUSE HOCKEY TERMS OF USE FOR SERVICES

Clubhouse Hockey is an Application / Website that endeavours to provide update competition information and offers opportunities through the Clubhouse Hockey services that aim to manage, promote, outsell and market private and or commercial interests and selling products to its Members. Members use the Clubhouse Hockey Application to register, discover, exchange and experience information in particular the match scores, competition information and ranking and/or use for organisational or sportive planning and will therefore create and offer private and public networks to its Members. The membership and therefore access to the services within the network accessible to every and any person or legal entity as long as the terms of use and end user licence is respected, including the general terms and conditions, the privacy and data protection policy and the confidentiality terms.

1. Clubhouse Hockey services. Beside the information network as described, Clubhouse Hockey offers companies the ability to promote products under private label and offers publicity space to companies in related activities. Moreover Clubhouse Hockey will offer, sell and promote products to consumers through its Application or Website called the Clubhouse Hockey store. Members will be free to purchase these products from Clubhouse Hockey as is and as available against payment and according to the laws on distance selling, whereby the customer will have a reflection period and the right to return the product against reimbursement within 14 days as from the expedition of the product. Therefore Clubhouse Hockey will sell in its own name and for its own account at fair market conditions including the legal warranties these Products and will distribute the Products upon demand and after payment is received.

2. Membership. Membership is open to all and every person who qualifies and accepts the terms and conditions. Specific terms are specified on the front website. Once membership is accepted, the member receives a licence and may freely use the Clubhouse Hockey services under the general terms and conditions and with respect to these user terms. Some services are included in the Membership and therefore free other services are remunerated. Services are payable when

clearly indicated and individually accepted (offering services or products through the Clubhouse Hockey network; advanced assistance; matching; premium pack).

3. Sponsorship. Clubhouse Hockey may encourage members to introduce new members. The system of parrainage is non-remunerated but can give reduction or free access to services. Parrainage is limited to an internal circle; public or general parrainage and or other remuneration being excluded. Clubhouse Hockey may also encourage organizers, ie. Members who will share and introduce information and updates aforementioned. Clubhouse Hockey may furthermore accept the placement of banners or other promotional material, including cookies and followers from third parties.

4. Usage Rules If you download the Software then, without derogating from the warranty disclaimers and limitation of liability as set forth in the general terms and conditions, becoming a Member :

(i) You acknowledge and agree that:

(a) this Agreement is concluded between Clubhouse Hockey and you only and Clubhouse Hockey and its organizers. Clubhouse Hockey is solely responsible for the Software and the content thereof, not for the services, the behaviour or the results of the members and network.

(b) the use of the Software is also subject to the Usage Rules established by any other provider including those set forth in the Apple App Store Terms of Service, effective as of the date that you enter into this Agreement; HP; google or other.

(c) the License granted herein is limited to a non-transferable right to use the Software on an PC; iPhone, iPod Touch, iPad, or other product that you own or control;

(d) Clubhouse Hockey is solely responsible for providing any maintenance and support services with respect to the Software, as specified in this Agreement, or as required under applicable law.

(e) Clubhouse Hockey is solely responsible for any service warranties, whether express or implied by law, to the extent not effectively disclaimed. In the event of any failure of the Software to conform to any applicable

warranty, you may notify Clubhouse Hockey, and Clubhouse Hockey will, to the extent applicable, refund not consumed paid services with a maximum of one month. To the maximum extent permitted by applicable law, Clubhouse Hockey will have no other warranty obligation whatsoever with respect to the Software, and, any other claims, losses, liabilities, damages, costs or expenses attributable to any failure to conform to any warranty will be Clubhouse Hockey's sole responsibility;

(f) Clubhouse Hockey is the between to the receiving of any complaint of a product default or failure of delivery of products sold and paid through its Application., and will support the customer with the replacement, but can never be held personally liable of the product; all claims on : (a) product liability; (b) remote or indirect damages to be addressed against the manufacturer and/or official dealer. Any claim that the Software fails to conform to any applicable legal or regulatory requirement; and claims arising under consumer protection or similar legislation, including in connection with the Software's use and or the distribution of the products sold and paid being warranted;

(g) in the event of any third party claim that the Software or your possession and use of the Software infringes that third party's intellectual property rights, Clubhouse Hockey shall not be responsible for the investigation defence, settlement and discharge of any such intellectual property infringement claim;

(h) Clubhouse Hockey and its organizers, are not responsible for the correctness of the information offered through the Application or Website. They can never be held responsible. However Clubhouse Hockey and the organizers endeavour to do their utmost best to the accuracy of the information and will upon first notice alter, modify or remove any information that is considered incorrect, misleading or incomplete.

(ii) Members represent and warrant that: (a) they are not located in a country that is subject to a U.S. Government embargo, or that has been designated by the U.S. Government as a "terrorist supporting" country; and (b) that are not listed on any U.S. Government list of prohibited or restricted parties. Members will always use the Application in good faith, without offending, mischieving, corrupting other Members or third parties, according to the standards of good and acceptable behaviour. Any infringement on these

standards or the terms and conditions may lead to exclusion of Membership and/or prosecution.

(iii) If you have any questions, complaints, or claims regarding the Software or services, please contact Clubhouse Hockey.

(iv) By entering into this Agreement you, to the extent legally permitted, hereby waive any applicable law requiring that this Agreement be localized to meet your language and other local requirements.
